Thank you for your recent assistance regarding vendor participation in The National Committee of Vital and Health Statistics - Subcommittee of Standards and Statistics' development of *Electronic Prescribing Standards*, as called for in the recently passed Medicare Prescription Drug, Improvement and Modernization Act of 2003 (Sec. 101, Subpart 1; Sec. 1860D-4 (e)).

Clearly, drafters can most benefit from those entities able to demonstrate superior knowledge of and value to key stakeholders in the electronic prescribing evolution. As such, HealthRamp is ideally positioned to participate in the development of electronic prescribing standards.
