## Some Knowledge/Skill Areas in Data Readiness (question 2)

- What secondary data are available on key local issues

How to:

- assess validity and reliability
- use data from multiple sources
- look at the interaction of health determinants and health outcomes
- choose and interpret measures/indicators, use them to monitor change
- collect data to increase knowledge
- use qualitative data to augment quantitative data
- use local data in ways that protect people's privacy
- address concerns about stigma
- build trust in the community

# Interview Themes & Observations (3 Areas + Roundtable)

## (1) Framing the topic

- Terminology
  - Readiness AKA activation, competencies, skills/skill sets, literacy, maturity
  - What communicates and frames the topic most effectively?
- Differentiate user types
  - Models of categories exist (Community Commons, SHADAC, et al.)
  - Which users should NCVHS target?
- Range of information functions involved
  - Where should NCVHS focus?

## **Interview Themes & Observations (3 Areas + Roundtable)**

### **(2) Current environment**

- Many communities already can do quite a lot.
- Community health needs assessment is a major focus, though incomplete w/o goals.
- Collective Impact is a spreading process model.
- State HDs and some county HDs can be important resources and models.

## Interview Themes & Observations (3 Areas + Roundtable)

### (3) Resources, assistance & NCVHS niche

- Resources & TA for communities exist, but hard to find w/o program/funding links
  - Exceptions: Community Commons, County Health Rankings & Roadmaps
- Goal-setting is key. Cognitive work analysis might help.
- Our informants agree on the potential usefulness of:
  - A tool for assessing competencies in specific data-related areas
  - Tools, resources, and/or pointers to existing resources
- How can NCVHS help data providers match resources to readiness types/stages/levels?
  - Keep it simple
  - Don't expect communities to do it all themselves
  - Help them figure out precisely what they need and where to find it
- **Possible resources (=NCVHS products or recommendations?)**
  - Resource directory
  - Simple pointers
  - A learning community
  - Online tools
  - Profiles of success
  - Regional Extension Center network adapted for this purpose?
- *Test a self-assessment tool in a Community Commons group space or blog?*
