## **National Committee on Vital and Health Statistics**

**Report to Congress** 

March 31, 2021





- Public advisory committee to HHS on health data, statistics, privacy, and national health information policy.
- Assist and advise the Department in the implementation of the Administrative Simplification provisions of the Health Insurance Portability and Accountability Act, and...inform decision making about data policy by HHS, states, local governments and the private sector.
- Monitor the nation's health data needs and current approaches to meeting those needs; identify emerging health data issues, including methodologies and technologies of information systems, databases, and networking that could improve the ability to meet those needs.





- Responsible generally for <u>advising the Secretary and the Congress</u> on the status of the implementation of part C of title XI of the Social Security Act.
- Assist and advise the Secretary in complying with the requirements imposed under Part C of Title XI of the Social Security Act.
- Study the issues related to the adoption of uniform data standards for patient medical record information and the electronic interchange of such information, and report to the Secretary recommendations and legislative proposals for such standards and electronic exchange.

# **NCVHS Report to Congress**



• **Primary Purpose:** Update on Implementation of the Administrative Simplification Provisions of HIPAA

• **HIPAA:** Requires the Secretary of HHS to adopt standards to support electronic information exchange for an efficient, effective healthcare system, including standards for security and privacy to protect individually identifiable health information.



...shall address the following subjects, to the extent that the Committee determines appropriate:

- The extent to which persons required to comply with Part C of the Act are cooperating in implementing the standards adopted under such part;
- The extent to which such entities are meeting the security standards adopted under such part and the types of penalties assessed for noncompliance with such standards;
- Whether the federal and State Governments are receiving information of sufficient quality to meet their responsibilities under such part;
- Any problems that exist with respect to implementation of such part;
- The extent to which timetables under such part are being met.

## Evolving Context for Health Information Policy: Five Major Trends in Health Information



- 1. New technologies, platforms, and models for managing health information—with varying degrees of maturity and implementation—have emerged to meet pressing information needs.
- 2. Patients' roles in accessing and using their health data have expanded and evolved.
- 3. The convergence of clinical and administrative data standards is gaining momentum.
- 4. The COVID-19 pandemic has exposed grave weaknesses in the public health information infrastructure.
- 5. Health information privacy and security challenges have proliferated.
