Meeting Background & Purpose:

NCVHS’ Subcommittee on Standards is seeking industry reaction to draft Considerations developed based on input and information gathered at the Subcommittee Listening Session held [August 25, 2021](#), and in response to its [request for information](#) to support its current project, “Standardization of Information for Burden Reduction and Post-Pandemic America” ([Convergence 2.0](#)).

HIPAA¹, HITECH², ACA³, 21st Century Cures⁴ and other federal legislation has positioned the industry well to begin conceptualizing a strategic vision for health information technology standards to support more broadly integrated health data flows. The Subcommittee’s Convergence 2.0 work also assesses the strengths and weaknesses of the current standards development and federal rulemaking processes to support this emerging landscape.

The Committee is seeking reaction to the draft Considerations from potentially impacted end-users of national standards and their IT systems vendors, including (but not limited to), standards development organizations, payer and provider trade and professional organizations and other members of the public.

Should the June 9 Listening Session reveal significant consensus on the draft Considerations, the Subcommittee will use the feedback to frame recommendations for consideration by the full Committee. If industry feedback indicates little or no consensus, then the Subcommittee will reconsider its approach as it continues in the second phase of the Convergence 2.0 project.
