- June 2022 Subcommittee Listening Session
 - Industry stakeholder roundtable discussion
 - Topics related to adoption of HIPAA standards, and new drivers in health care data exchange.
 - Letter to HHS proposed four actionable recommendations for consideration
- Regular Subcommittee engagement with leadership from the Office of the National Coordinator (ONC) and Office of Burden Reduction and Health Informatics (OBRHI)

Recommendations to HHS (June 2022)



- Recommendation 1: Update relevant HIPAA policies to allow the adoption and use of more than one standard per business function.
- <u>Recommendation 2</u>: Enable HIPAA Covered Entities to support one or more versions of adopted standards for business functions.
- <u>Recommendation 3</u>: ONC's existing authority be expanded to facilitate the coordination of Social Determinants of Health (SDoH) data standards efforts across HHS agencies and offices (e.g., CMS, ONC, CDC, NIH, IHS), to include a formalized public process that would include non-federal entities (e.g., State, Tribal, Local and Territorial governments (STLTs), private health and healthcare systems) to align national standards with evolving and complex national and local reporting and information needs.
- <u>Recommendation 4</u>: HHS develop and publish a guidance framework for Standard Development Organizations and other industry stakeholders that outlines how to develop and report measures for new and revised standards readiness, costs, and overall adoption value to support HIPAA standards development, testing, evaluation and adoption.

Updating Standards and Operating Rules



Requests from X12 and CAQH CORE

Role of NCVHS



Roles and Responsibilities for NCVHS

- Receive requests for new or updated standards and operating rules from Standards Development Organizations (SDOs) and Operating Rule Authoring Entities (ORAEs);
 - For updated standards, obtain input from industry, including Designated Standards Maintenance Organizations (DSMOs), i.e., ADA, HL7, NCPDP, NUBC, NUCC, and X12 regarding the requested modifications;
 - For updated and new operating rules, obtain industry input on how the operating rules support the adopted HIPAA transactions
- Make recommendation(s) to the Secretary of HHS

Transaction Standards & Operating Rules

Transaction standards are:

- the electronic exchange of health-related information between two parties to carry out financial or administrative activities.
- HHS has adopted certain standard transactions for the electronic exchange of health care data under HIPAA.

Operating rules are required by the Affordable Care Act

- Operating rules are defined as the "Necessary business rules and guidelines for the electronic exchange of information that are not defined by a standard or its implementation specifications;
- Business rules and guidelines do not duplicate what is in the standard and may not be inconsistent or in conflict with the standard. Operating rules typically go above and beyond the standard in terms of data content and other requirements."

X12 Request to Update HIPAA Transactions



- X12 has requested NCVHS recommend that the Secretary adopt version 8020 for certain transaction implementation guides:
 - Claims (837 Professional, Institutional and Dental)
 - 2021 CAQH Index adoption rates: 97% (Medical) and 84% (Dental)
 - Payment/Remittance Advice (835)
 - 2021 CAQH Index adoption rates: 76% (Medical) and 84% (Dental)
- Move from Version 005010 to Version 008020
 - 5010 balloted by X12 2003; adopted under HIPAA 2009; implemented 2012
- All other adopted transactions remain on version 5010

 - Replaces existing connectivity requirements in infrastructure components of adopted operating rules and adds new requirements to all operating rules
- Eligibility & Benefits (270/271) Single Patient Attribution Data Content Rule
- Attachments Prior Authorization Infrastructure Rule*
- Attachments Prior Authorization Data Content Rule*
- Attachments Health Care Claims Infrastructure Rule*
- Attachments Health Care Claims Data Content Rule*

 - Need for and impact on implementation of proposed new operating rules.
 - Available cost benefit information for implementation of either updated version of the standard transactions, and updated or new operating rules.
 - How the requests from X12 and CAQH CORE support the objectives of HIPAA and ACA.
 - Other information to support Subcommittee feedback to HHS
