- Consultative conversations with CMS/OBRHI, CMS/NSG and HHS ONC¹
- NCVHS hearing January 18 & 19, 2023 (virtual)

Additional proposals from CAQH/CORE for Operating Rules

- Connectivity Rule vC4.0.0 (includes updates to the Connectivity Rule included in existing operating rules)
 - Replaces existing connectivity requirements in infrastructure components of adopted operating rules and adds new requirements to all operating rules

Background



Per Section 1104 of the Affordable Care Act, which amended Section 1173 of HIPAA, operating rules are business rules and guidelines for the electronic exchange of information that are not defined by a standard or its implementation specifications.

The Secretary shall adopt a single set of operating rules for each transaction, with the goal of creating as much uniformity in the implementation of the electronic standards as possible. Operating rules shall be consensus based and reflect the necessary business rules affecting health plans and health care providers and the manner in which they operate to **support the standards adopted under HIPAA.**

Role of NCVHS in Making Recommendations to HHS on Operating Rules



- Advise the Secretary as to whether a nonprofit entity meets certain requirements to serve as an authoring entity for operating rules;
- Review the operating rules developed and recommended by the nonprofit entity;
- Determine whether operating rules represent a consensus view of the health care stakeholders and are consistent with and do not conflict with other existing standards;
- Evaluate whether such operating rules are consistent with electronic standards adopted for health information technology; and
- Submit to the Secretary a recommendation as to whether the Secretary should adopt such operating rules.

Process and Agenda

- Presentation by CAQH CORE to describe their request and proposals.

NCVHS Process



NCVHS is gathering industry input/consensus about:

- Value-add of proposed updates to operating rules
- Benefits and applicability to the HIPAA standards to which operating rules apply (mandatory) and those that may be used voluntarily
- Availability of cost-benefit information for implementing updated operating rules
- Expected business process improvements
- Changes to the companion guide template and the benefits of these changes.
- Implications of proposed operating rules for attachments for claims and for prior authorization
- Impacts of adopting or not adopting the proposed operating rules
