80% of budget goes to the Extramural community

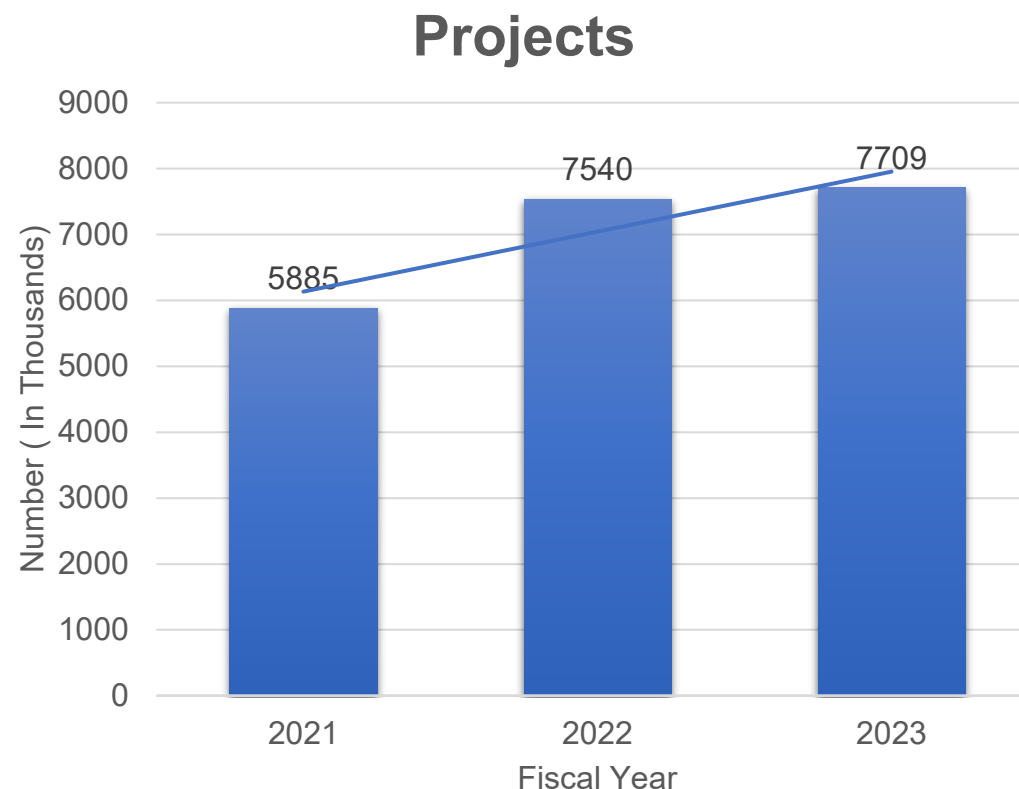
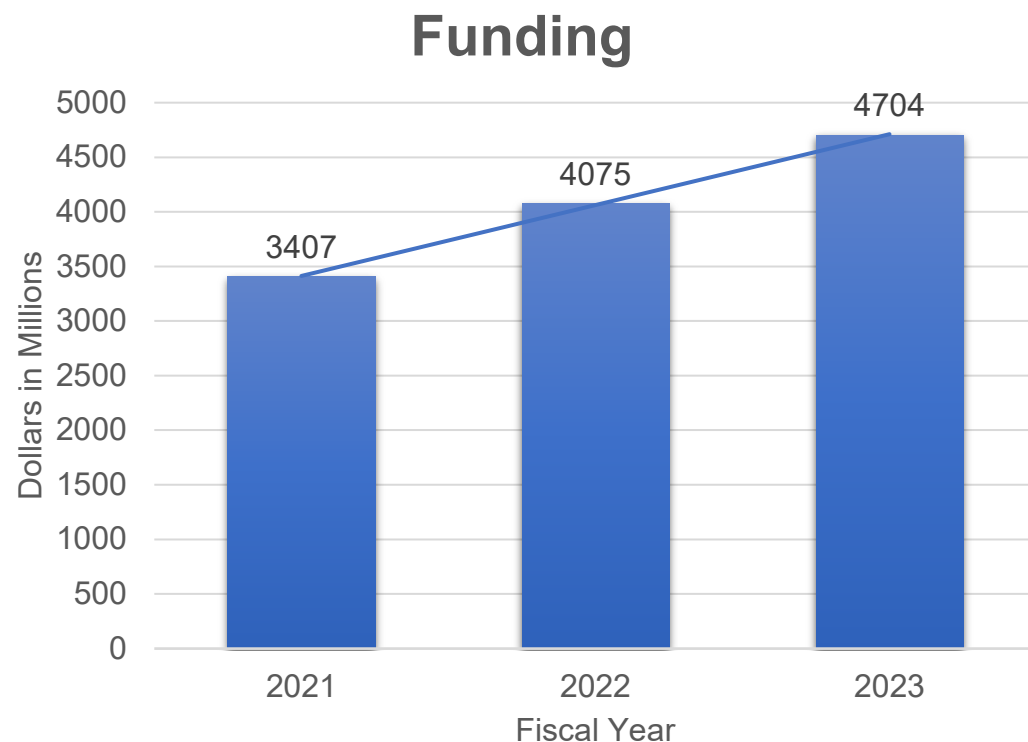

The *All of Us* Research Program: An Innovative Research Effort

- **Diversity at the scale of 1 million people or more**
- **Focus on participants as partners**
- **Longitudinal design, ability to recontact**
- **Multiple data types:** EHR, surveys, baseline physical measurements, biospecimens, genomics
- **National, open resource for all:** Broadly accessible to all researchers with open-source software & tools
- **Security and privacy safeguards** for all participant data

The SDOH Survey from *All of Us*

- Launched in November 2021 to collect information about social and environmental factors that influence everyday life
 - Diverse sample; 80% underrepresented in biomedical research
 - Missing Data on certain measures (i.e. race/ethnicity, age, SES)
 - Relunched the survey with a more targeted and prioritized approach to increase completion rate- later surveys having fewer responses compared to earlier versions

- SDOH Core Collection Launched in May 2020
 - SDOH Core Collection-16 protocols recommended*
 - Individual SDOH- 23 protocols
 - Structural SDOH- 14 protocols
- Relevant for advancing minority health and health disparities research
- Supports in-depth assessments on SDOH topics
- Low burden protocols; comparable across NIH studies

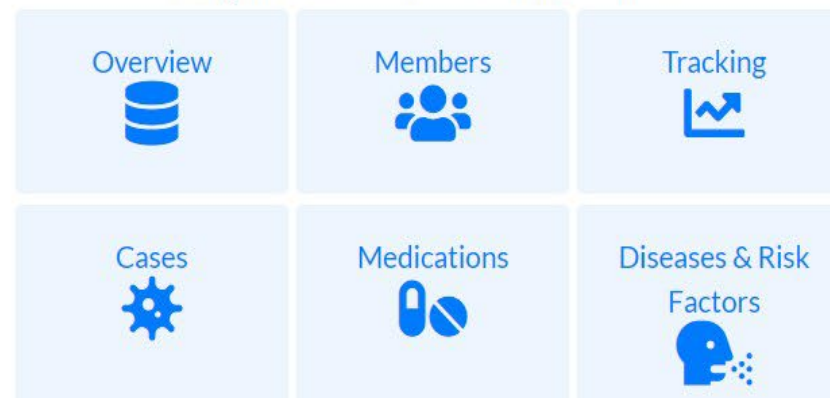


The N3C Data Enclave represents one of the largest secure collections of harmonized clinical health data in the United States.

Addressing the Impact of Structural Racism and Discrimination on Minority Health and Health Disparities

- 38 grant awards funded by 14 Institutes and Centers in FY 2022; \$125 Million over 5 years
- The initiative supported: (1) observational research to understand the role of structural racism and discrimination (SRD) in causing and sustaining health disparities, and (2) intervention research that addresses SRD in order to improve minority health or reduce health disparities.
- Relevant to SDOH by building on institutional racism; neighborhood and community and societal domains that are known to condition additional health risks in populations that experience health disparities

Community Partnerships to Advance Science for Society (ComPASS)

To advance the science of health disparities and health equity research, the NIH Common Fund launched the ComPASS Program.

The goals of ComPASS are to:

1. Catalyze, deploy, and evaluate **community-led health equity structural interventions** that leverage partnerships across multiple sectors to reduce health disparities
2. Develop a **new health equity research model** for community-led, multisectoral structural intervention research across NIH and other federal agencies

Program duration: 10 years

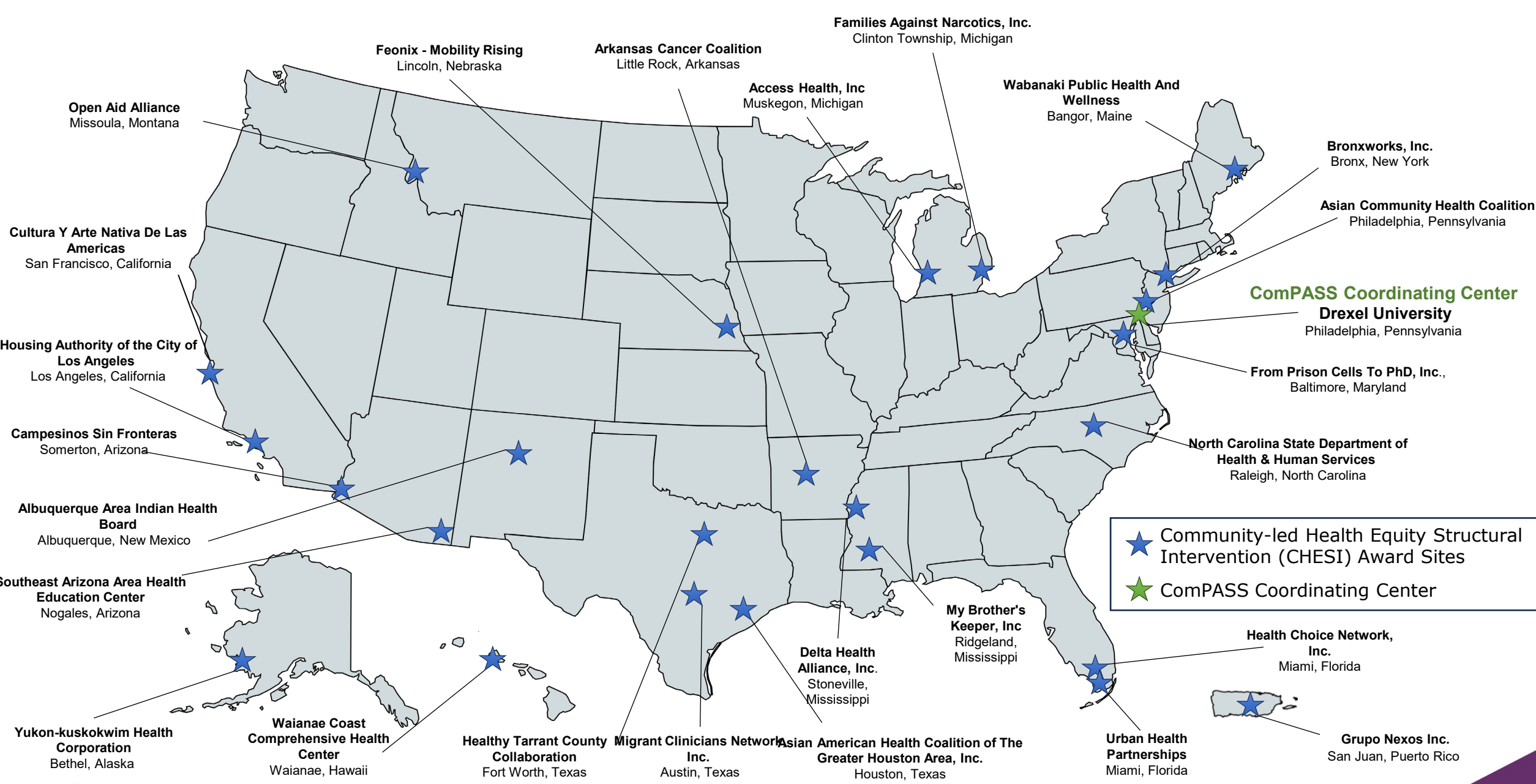
Planned budget: Approximately \$200M in the first five years

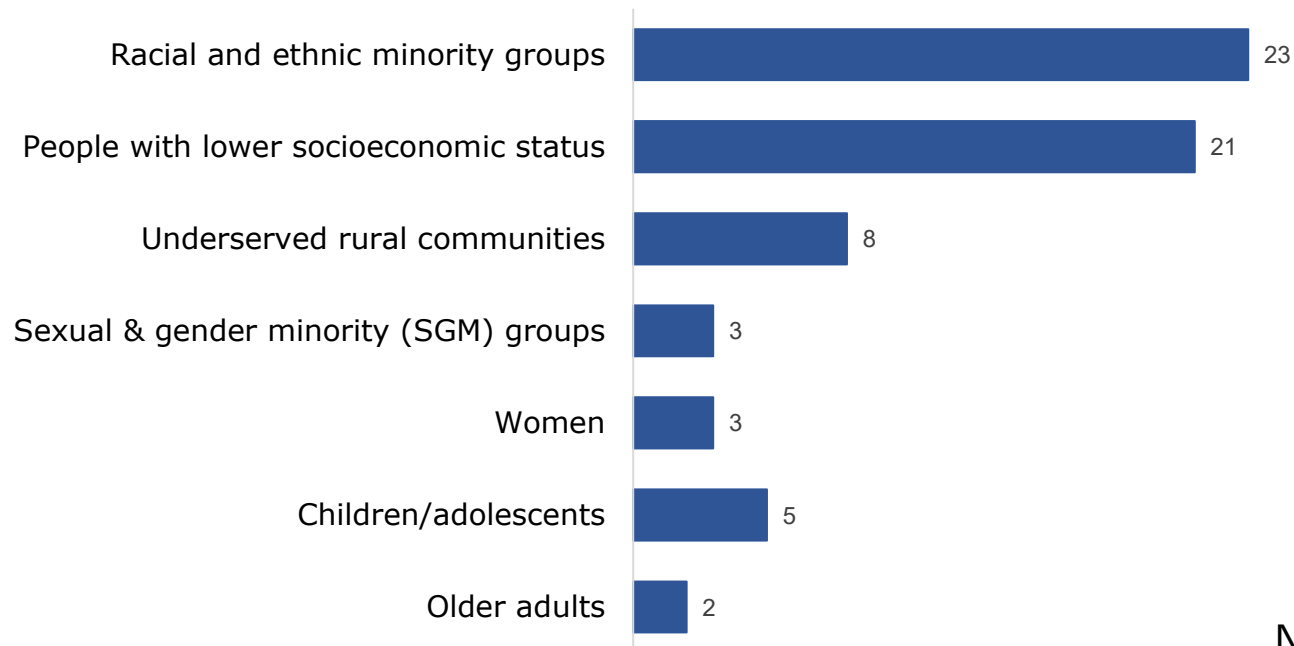

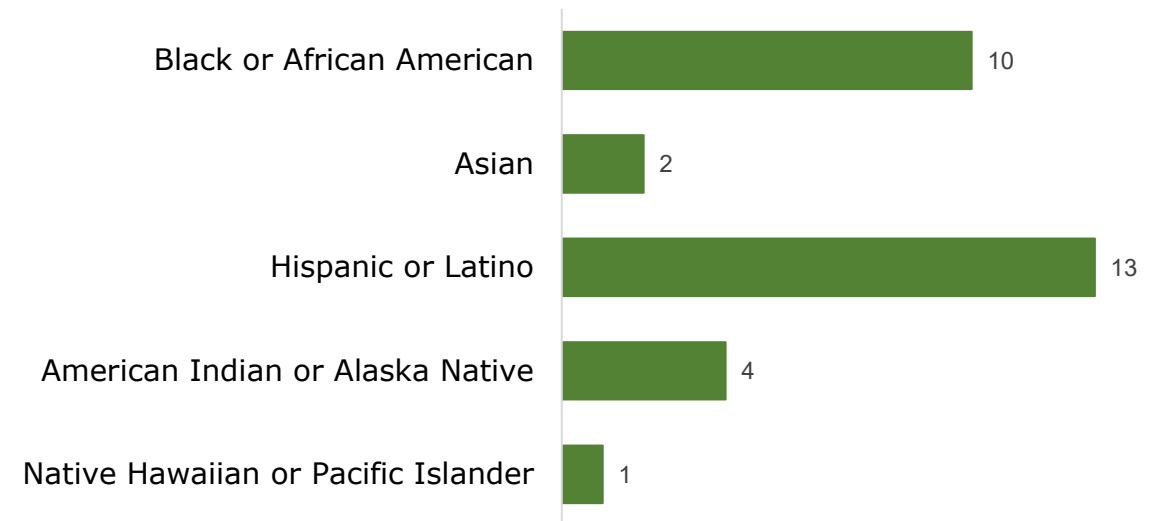


25 Community-Led, Health Equity Structural Interventions: Populations
